"Stand Your Ground" (No Retreat) rule which bars the prosecution of people who use deadly force against a deadly aggressor without first attempting to retreat, or offers such persons a valid self-defense claim against a charge of criminal homicide' By contrast, a minority of states enforce a "Retreat"
